

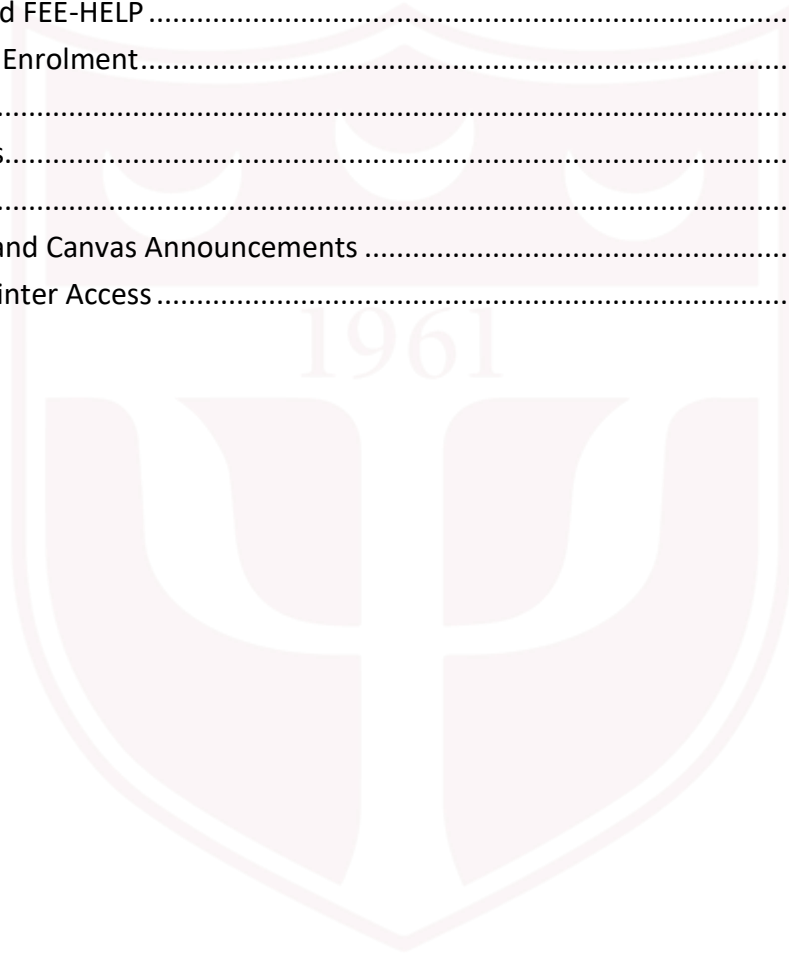

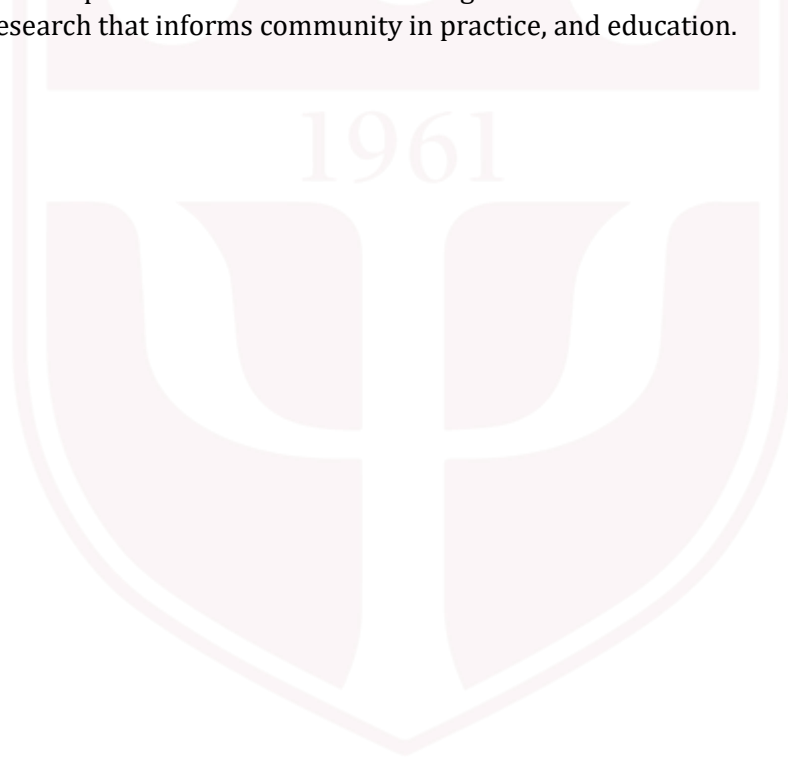

# The Cairnmillar Institute

# Master of Clinical Psychology (Post Registration)

Clinical psychology is an area of psychological practice that incorporates science, theory, and clinical practice through diagnosis, prevention and treatment of psychological problems and mental illness. Clinical psychologists are located in private practice, hospitals, universities, general medical practices, community health centres and mental health services. They work with infants, children, adolescents, and adults of all ages. They are also involved in designing, implementing and evaluating a wide range of prevention and mental health promotion programs.

The course is accredited by the Australian Psychology Accreditation Council (APAC) as a standalone AQF level 9 program leading to professional competencies in clinical psychology as a specialised area of practice.

On successful completion of this course, graduates will be eligible for the Psychology Board of Australia (PsyBA) Registrar Program in clinical psychology. Graduates will be required to complete a supervision plan approved by the PsyBA in order to be accepted as registrars, followed by a minimum of 88 weeks (3,000 hours) of supervised practice for the purpose of gaining registration with endorsement in the area of clinical psychology. For psychologists who already hold an area of practice endorsement, the registrar program is 2,250 hours.

## Entry Requirements

Students accepted into the course must have successfully completed a four-year, or three-year plus a fourth year, APAC-accredited sequence in psychology. Students must hold general registration as a psychologist with the Australian Health Practitioner Registration Agency (AHPRA), with no conditions on their registration, and have practiced for at least 12 months full time or equivalent OR have completed a Level 3 APAC-accredited Master of Professional Psychology and hold general registration. Students are required to complete an application form, submit a video, undertake a referee check and be able to demonstrate that they have met all APAC level three professional competencies by completing and passing the Cairnmillar Psychology Competency Exam. Students who have not completed a Level 3 qualification previously will also be required to undertake a short research course prior to enrolment.

An order-of-merit for entry will be prepared taking into account (a) academic record, (b) responses to application questions and a video, (c) academic and professional referees' reports, and (d) psychology competency exam score.

## Psychologist Registration and Insurance

All students are required to maintain general registration as a psychologist with AHPRA for the duration of their enrollment and will be asked to provide a copy of their registration certificate prior to commencement on the course, prior to commencing a placement, and/or each time that their registration is renewed during enrollment. You must report any new notifications made about you to AHPRA and any changes to the nature of your professional registration as a psychologist (including any changes relating to conditions, undertakings, and reprimands) to the Course Coordinator within 7 days of being made aware of them. Students are also required to have the appropriate child protection and police checks, depending on which state they are practicing in. These must be maintained throughout the course.

You will be covered by the Cairnmillar Institute's Professional Indemnity Insurance for approved educational activity (e.g., placements) only if you are an enrolled student. Students must not let their enrolment lapse while on placement and must maintain their own appropriate level of insurance (if required) for all work outside of placement.

## Duration of the Course

This course is designed to be completed 24 months part-time. It consists of 4 units of traditional coursework, 2 research units and 2 placements.

## Course Learning Outcomes

- Apply the AHPRA Code of Conduct as well as relevant legislation that informs current professional practice.
- Develop knowledge of a broad range of assessment measures and demonstrate an understanding of the theoretical frameworks and psychometric properties that support their empirical validation.
- Demonstrate an understanding of a select range of empirically validated interventions suitable for use with adults and children.
- Demonstrate an understanding of interventions used for work with clients who have complex presentations.
- Demonstrate an expert understanding of a topic relevant to clinical psychology. This understanding is exhibited by the ability to: interpret previous findings and developments relevant to their research in clinical psychology and devise an original research project that is based on sound and current research methods.

## Career Opportunities

Graduates may gain employment in community mental health centers, psychiatric hospital settings, specialist services for particular clinical groups, schools, tertiary education, clinical rehabilitation services and private practice.

## Professional Recognition

Graduates will be eligible to apply for registration with the Psychology Board of Australia as a Clinical Psychology Registrar. On completion of a minimum of 88 weeks (3,000 hours) of supervised experience (or 2,250 if bridging to a second endorsement) subsequent to graduation from the program, graduates will be eligible to apply for endorsement in clinical psychology, and to be clinical psychology practitioners with Medicare Australia.

Graduates of this course will also be eligible to become Associate Members of the Australian Psychological Society (APS) College of Clinical Psychologists, and on completion of a PsyBA-approved registrar program, to be a Fellow of the College. Full membership of other professional organisations (e.g. Australian Clinical Psychology Association) will also become available.

**Corequisite 2:** CLP652 (Research Project B) must be completed concurrently with CLP665 (Placement B)

## Coursework & Placement Units

### Coursework

Each of the units of study are detailed below. Students must pass all units before being eligible to graduate. In CLP601, the first assessment is a hurdle task and must be passed to pass the unit. In the remaining coursework units, all assessment tasks do not necessarily need to be passed to pass the unit, as long as the final mark for the unit is over 50%. The workload associated with each unit varies and is described in more detail in the Unit Outline. For each 12.5 credit point unit, expect to spend around 3 hours per week viewing recorded material and attending tutorial activities, and approximately 6 additional hours undertaking further study, completing assignments and preparing for exams.

## Placements

Students will undertake two external field placements (CLP664 & CLP665). These should take place in a variety of settings to maximise students' exposure to a range of clients, levels of severity, and experiences. Students will be expected to engage in direct clinical psychological work with clients across the lifespan, and in varied settings (please refer to the placement information handbook for more detail). In most circumstances, students identify their own placement opportunities (The Cairnmillar Institute occasionally has a small number of placements that students can elect to apply for on an EOI basis). All prospective placements need to be assessed as suitable clinical psychology placements by the Placement Coordinator and may include assessment by the Course Coordinator. All supervision (a mixture of individual and group formats) is provided by CMI-appointed supervisors and will be organised by the Cairnmillar Institute. Whilst individual supervision is intended to provide content-specific supervision directly relevant to your placement experience, group supervision is intended to offer a broader experience with opportunities to learn from students undertaking a more diverse range of activities.

## Unit Summaries

### **CLP601 (Clinical Psychology: Theory and Practice)**

This unit focuses on developing advanced knowledge and skills required for the ethical practice of clinical psychology. Topics include ethical, legal and professional considerations, developments in interprofessional learning and culturally responsive practice. The unit also covers a critical appraisal of evidence-based interventions, and diagnostic taxonomies, an overview of measurement-based care, psychopharmacology, and issues relating to self-care and preventing burnout.

### **CLP602 (Advanced Assessment for Clinical Psychologists)**

The aim of this unit is to develop competence in culturally responsive assessment in clinical psychology. It focuses on advanced knowledge and skills in clinical psychology evaluation using diagnostic taxonomies, selection and administration of assessment tools and psychometric tests, assessing risk to self and other, the limitations of currently available instruments with culturally diverse groups, interpretation and communication of clinical psychology assessment data, use of diagnostic assessment data and case formulation to inform intervention, and understanding specific ethical and professional issues related to clinical psychology assessment.

### **CLP604 (Psychopathology and Intervention for Adults)**

This unit aims to develop students' knowledge and skills in diagnosis, formulation, and treatment of mental health conditions. The conditions are examined through various theoretical and conceptual lenses, including consideration of culture, diversity, and lifespan, as well as different therapeutic modalities and interprofessional issues. Each week, considerations regarding diagnosis, formulation and intervention for a group of mental health condition is covered, including: anxiety, depression, psychotic presentations, eating-behaviour presentations, as well as addiction, trauma, and conditions involving somatic symptoms.

### **CLP603 (Psychopathology and Intervention for Children and Youth)**

The aim of this unit is to develop competence in culturally responsive conceptualisation, diagnosis and intervention in child and adolescent psychopathology. Students will acquire the clinical knowledge and skills necessary to assess, diagnose and treat childhood and youth mental disorders. A range of child and youth mental disorders will be addressed, including attachment disorder, internalising and externalising disorders, neurodevelopmental disorders (autism spectrum disorder), and early psychosis. There will also be discussion of other treatment modalities, including e-health approaches.

### **CLP651 (Evidence Based Project A)**

The unit requires students to begin an integrative evidence-based case study in the area of clinical psychology. A research proposal will precede a 3000 word introduction, comprising a 2000 word literature review and a 1000 word theory-practice links table, relevant to the clinical case study undertaken in CLP 652 (evidence based project B). Students will be expected to demonstrate application of knowledge and skills gained through the course. There will be some online classes to prepare students to complete the literature review. Students are encouraged to identify a case study that is highly relevant to the clinical setting(s) where they will be working and to complete a project that will provide them with evidence-based guidance for their work.

### **CLP652 (Evidence Based Project B)**

The unit requires students to complete the integrative evidence-based case study in the area of clinical psychology, undertaking corrections to the literature review completed in CLP651 (Research A) and completing a 3,000-word case study report. Students will be expected to demonstrate application of knowledge and skills gained through the course. There will be some online classes to prepare students to complete the case study. At the conclusion of the unit, students will submit a corrected version of their literature review, a summary of the changes they made in response to marker feedback, and their clinical case study.

### **CLP664 (Supervised Clinical Placement A)**

This is the first of two placement units. It comprises 375 hours of clinical placement which is designed to provide students with experience in the delivery of clinical psychology services. Students will be under the direct supervision of a clinical psychologist who has current area of practice endorsement and recognition as a higher degree supervisor by the Psychology Board of Australia (PsyBA). The first 200 hours of placement will have more frequent supervision (one hour for every 7.5 hours of placement), and students may see fewer clients initially in order to provide space for reflection and planning. Following this, the remainder of the placement will be supervised at 1 hour for every 15 hours of clinical practice.

### **CLP665 (Supervised Clinical Placement B)**

Placement Unit B comprises 375 hours and is designed to provide students with further experience in the delivery of clinical psychology services to build upon the introductory experience obtained in Placement A.

As in Placement A, students will be under the direct supervision of a clinical psychologist who has current area of practice endorsement and recognition as a higher degree supervisor by the Psychology Board of Australia (PsyBA). One hour of supervision will be provided for every two days (15 hours) at placement.

The penalty for late submissions is 5% of the total assessment mark per day (including weekends and non-business days), for a maximum of seven (7) days (i.e., maximum late penalty deduction possible is 35%).

Work handed in more than one week late will not normally be marked and a fail result will be recorded. No assignment will be accepted once the results for that assignment have been published. Tasks that are required to be completed and/or submitted in-class, such as class presentations must be submitted on the date of the class presentation unless a student has been granted special consideration. The penalty for late submission or non-submission of in-class tasks is usually 100% of the mark.
